### Amar Bhattacharya

Amar Bhattacharya is Senior Fellow at the Global Economy and Development Program at Brookings Institution. His focus areas are the global economy, development finance, global governance, and the links between climate and development.

From April 2007 until September 2014 he was Director of the Group of 24, an intergovernmental group of developing country Finance Ministers and Central Bank Governors. In that capacity he led the work program of the Group, supported the deliberations of the Ministers, and was the principal point of interface with other organizations including the G20. He has therefore been an active participant in the global economic discussions and a key representative of the views of developing countries.

Prior to taking up his position with the G24, Mr. Bhattacharya had a long-standing career in the World Bank. His last position was as Senior Advisor and Head of the International Policy and Partnership Group. In this capacity, he was the focal point for the Bank's engagement with key international groupings and institutions such as the G7/G8, G20, IMF, OECD and the Commonwealth Secretariat.

Through these different positions Mr. Bhattacharya has had a long standing engagement in research and policy discussions on the global economy and spillovers, international financial architecture, development financing and the global governance agenda including on the role and reform of the international financial institutions. He completed his undergraduate studies at the University of Delhi and Brandeis University and his graduate education at Princeton University.



#### Andriano Jose Timossi

Mr. Andriano Jose Timossi is a Senior Programme Officer at the South Centre. He has a Bachelor degree in Agricultural Science in Brazil and a Master's Degree in European Studies, in Italy. He works on UN multilateral agenda, in particularly, on development and human rights issues, South-South Cooperation and outreach, communications, strategic planning and partnership activities of the South Centre. Previously, he worked for UN agencies on socio-economic and development issues including the United Nations Office of the High Commissioner on Human Rights (OHCHR) at the Right to Development Section, including on unilateral coercive measures and as assistant to the Human Rights Council mandate holder on International Solidarity. He also worked for the United Nations Conference on Trade and Development (UNCTAD) on different divisions, including the Unit on Economic Cooperation and Integration among Developing Countries at the Office of the Secretary General of UNCTAD. Previously to the UN he also worked and trained in several organizations including Oxfam, European Commission, Scottish Parliament and Swiss Development Cooperation Agency. Most recent academic experiences includes London School of Economics (LSE) and Political Science and Peking University course China's foreign relations with East Asia in Beijing, China; LSE-Cape Town University course on Africa in Cape Town, South Africa; Research Information System for Developing Countries (RIS) course on Global Transformation: The rise of emerging powers and a new international order and International Economic Issues and Development Policy (IEIDP) in New Delhi, India and Contemporary Issues on International Relations at the Universidade de São Paulo (USP) in Brazil. His areas of interest include BRICS, G20, South-South Cooperation, Regional Integration, UN Development and Human Rights pillar, and Sustainable Development agenda.



#### Ambassador Andrés Rozental

Andrés Rozental was a career Mexican diplomat for more than 35 years, having served his country as Deputy Foreign Minister (1988-1994), Ambassador to Sweden (1983-88), Permanent Representative of México to the United Nations in Geneva (1982-83) and Ambassador to the United Kingdom, (1995-1997) as well as in various responsibilities within the Mexican Foreign Ministry and abroad. Since 1994, he holds the lifetime rank of Eminent Ambassador of México.

Currently retired from public service, Ambassador Rozental holds non-executive Board positions in several important multinational companies in Brazil and México. He chairs the Board of ArcelorMittal Mexico and is an independent Board member of ArcelorMittal Brazil, Ocean Wilson Holdings and Wilson Sons (Brazil) and HSBC Bank in Mexico. He has held advisory positions with Airbus, Toyota and Kansas City Southern de México.

He is President of his own consulting firm, Rozental & Asociados, which specializes in advising multinational companies on their corporate strategies in Latin America. He is also active in a number of non-governmental organizations and projects relating to global governance, migration policy, climate change, Latin American politics and the promotion of democracy. He is a Senior Nonresident Fellow at the Brookings Institution, a Senior Policy Advisor at Chatham House in London, a Trustee of the Migration Policy Institute in Washington and sits on the Operating Board of Canada's Centre for International Governance Innovation (CIGI) in Waterloo.

Ambassador Rozental was the Founding President of the Mexican Council on Foreign Relations (Comexi) and is currently a member ex oficio of its governing body.

Ambassador Rozental obtained his professional degree in international relations from the Universidad de las Américas in México, and his Master's in International Economics from the University of Pennsylvania. He is the author of four books on Mexican foreign policy and of numerous chapters and articles in edited volumes on international affairs, diplomacy, US-Mexico relations, among others. He is a regular contributor to print, radio and television media in Mexico, the United States and Europe.



#### Antonio Villafranca

Antonio Villafranca is Senior Research Fellow and Head of the Europe Programme at ISPI. He teaches International Relations at the Bocconi University and European Policies at the IULM University. At ISPI, he is currently in charge of 2 research projects - Gr:een and Rastanews - funded by the European Commission under the VII Framework Programme. In network with the London School of Economics he coordinates a project providing analyses and advice on international trade to the European Parliament. He is also non-resident senior fellow at the Chongyang Institute for Financial Studies (RDCY, Renmin University, Beijing).

In 2011, he took part in the "International Visitor Leadership Program" of the US State Department. He has extensively published on EU policies and European/global economic governance.

Caner Bakir is Associate Professor of Political Science, with a special focus on International and Comparative Political Economy, and Public Policy and Administration at Koc University, Istanbul. He received his PhD in Political Science from Monash University in Melbourne. He is Co-director of Center for Globalisation, Peace and Democratic Governance (GLODEM). He is the Associate Editor of Policy Sciences. His work relates to political economy and public policy with special emphasis on comparative institutional analysis and policy change. His research interests include varieties of national financial systems, the political economy of central banking, financial regulation and governance, state and international business relations, Turkish multinationals and macroeconomic bureaucracies. He has published articles in leading journals such as Governance, Public Administration, Development and Change, and New Political Economy. He is the author of Bank Behaviour and Resilience: Effect of Structures, Institutions and Agents (Palgrave MacMillan 2013), Merkezdeki Banka [Bank in the Centre] (Bilgi University Press 2007), and (with Louis Brennan) of Emerging Market Multinationals in Europe (Routledge forthcoming). He is the recipient of The 2010 Scientific and Technological Research Council of Turkey (TUBITAK) Incentive Award, and TUBITAK Early Career Award in 2008. ## Dr. Cengizhan ÖZTÜRK

Dr. Ozturk received his M.D. from Marmara School of Medicine, Istanbul, in 1990. He proceeded with a Specialization in Physiology from Cerrahpasa Medical Faculty, Istanbul University, in 1994 and finally with a Ph.D. at the School of Biomedical Engineering, Science and Health Systems, Drexel University, Philadelphia, in 1997. During 1997-2000, he worked as a postdoctoral research fellow at Medical Imaging Lab, Department of Biomedical Engineering, Johns Hopkins University, supervised by Dr. Elliot McVeigh. At JHU, his research focus switched to MRI. Since September 2000, he is working as a faculty member at the Institute of Biomedical Engineering (BME), Bogazici University, Istanbul. He established Bogazici University Medical Imaging Laboratory (BU-MIL), where on average 15-20 graduate-level BME students at any given time perform their research on a wide-gamut of medical imaging topics. Dr. Ozturk managed to hold a parallel visiting research scientist position at Cardiac Interventions Program, NHLBI, NIH, for five years (2002-2008). His research at NHLBI focused on real-time MRI, XMR fusion and MR-guided medical interventions.

Between 2008-2013, Dr. Ozturk coordinated a universitywide effort to establish a multidisciplinary research center focused on life sciences and health technologies, funded by the Turkish Ministry of Development. The Center for Life Sciences and Technologies of Bogazici University is now supported by over 60 faculty members distributed among 11 academic departments/institutes. It is currently in its rollout phase of several important national research infrastructures: 1) Microsystem Based in vivo Device Development Laboratory with a dual-purpose clean room that combines MEMS capability with medical plastic/metal processing for development of novel interventional devices and sensors, 2) Small Animal Research Center (Vivarium) with transgenic capabilities, 3) Smart Drugs Laboratory with a focus on nanoparticles and implantable medical device surface preparations.

Since 2011, Dr. Ozturk is also coordinating the Istanbul Cooperation Platform for Life Sciences and Technologies (Inovita), funded by Istanbul Development Agency. Main focus of Inovita is to create an environment to foster translational research and entrepreneurial activities in health technologies. Currently, Inovita is establishing a small model incubator/accelerator with a strong mentorship focus for early health tech startups at Bogazici University. It is also contributing to many other incubator efforts on life sciences and to other biotechnological infrastructure development projects regionally. Dr. Ozturk coordinates the establishment of reference labs and common production facilities at Teknopark Istanbul for a larger health technology industrial cluster. ISEK (Istanbul Health Industry Cluster, İstanbul Sağlık Endüstrisi Kümelenmesi) formally established at the beginning of 2014 with over 90 members.

He is also Head of Section, Global Programmes within the German International Cooperation Agency's (GIZ) Global Partnerships and Emerging Economies Division and Director of GIZ's Emerging Market Sustainability Dialogues Programme. Prior to his current role he worked as an advisor on corporate social responsibility in China and on private sector development in Laos. He started his career as a strategic management consultant, investment banking analyst and financial sector economist in London, UK. Daniel studied economics, finance and Chinese economy and management at the London School of Economics (LSE), Cambridge University, the School of Oriental and African Studies (SOAS), and Peking University. #### Domenico Lombardi

Domenico Lombardi is director of CIGI's Global Economy program, overseeing the research direction of the program and related activities. He also serves as Chair of The Oxford Institute for Economic Policy and sits on the advisory boards of the Bretton Woods Committee in Washington, the G20 Research Group and the G8 Research Group at the University of Toronto, and the Istituto Affari Internazionali in Rome. Mr. Lombardi is a member of the Financial Times Forum of Economists and editor of the World Economics Journal.

In 2011, he served as the rapporteur for the High-Level Panel on the Governance of the Financial Stability Board. A year earlier, he was appointed by the World Bank Group's Board of Directors as the External Reviewer to conduct the first independent review of the Group's Oversight and Accountability Units. In 2009, Mr. Lombardi authored the report to the IMF Managing Director on IMF Governance Reform ("Fourth Pillar Report"). Prior to that, Mr. Lombardi's distinguished career includes positions on the executive boards of major international financial institutions such as the International Monetary Fund and the World Bank.

His academic interests focus on the global economy and currencies, global governance, the G20, the G8, and the reform of the international financial and monetary system. His research has been published in peer-reviewed journals and has been referred to in Congressional and Parliamentary hearings around the world. He has testified before the U.S. Senate Committee on Banking, Housing, and Urban Affairs and the Subcommittee on Security and International Trade and Finance. Mr. Lombardi has an undergraduate degree summa cum laude in Banking and Finance from Bocconi University, Milan, and a Ph.D. in economics from Oxford University (Nuffield College).

Head of the Program on Contemporary Turkey

Institut français des relations internationales (French Institute of International Relations, Ifri), Paris, France.

A graduate of Sciences Po Paris with a doctorate in political science from the University of Paris II Panthéon-Assas, Dorothée Schmid joined Ifri in 2002 to study European policies in the Mediterranean and the Middle East as well as French policy in the Arab world. In 2008, she founded the Program on Contemporary Turkey, which she currently heads. Before dedicating herself to research, Dorothée Schmid worked as an analyst of country-risk at Crédit agricole Indosuez then as the leader of the Euromed mission for Cités Unies France, a federation of local French authorities working on the international stage. She has led numerous consulting missions for various public institutions (the European Commission, the French Ministry of the Economy, the French Ministry of Foreign Affairs), NGOs, and businesses. The Program on Contemporary Turkey at Ifri focuses on the political and economic developments in Turkey, the hazards of the negotiations for admission to the European Union, and Turkey's new diplomatic ambitions. The Program currently contributes to the development of the bilateral debate between France and Turkey.

Dorothée Schmid's other interests include the political economy of the Middle East as well as the political transitions and the relationship among powers in the region.

Dr. Hufbauer holds an A.B from Harvard College, a Ph.D. in economics from King College at Cambridge University, and a J.D. from Georgetown University Law Center. He has written extensively on international trade, investment, and tax issues.
