








Harmonized index of consumer prices (annual change, %)

Unemployment rate (%), September






Figure 2.6: Cumulative Employment Growth by Sector in 2000-2005, %




Figure 1.1: Bulgaria's Convergence Challenge




Income tax rates (%)



Maximum rate




Corporate tax rate (%)


