


□21 Feb. 2001 – Struggle between President of Turkey and Prime Minister, caused an
"Economic Criss" called black Wednesday
☐Withdrawals from Central Bank reached to 7,5 billion US\$
☐22 Feb. 2001 - Government announced new exchange rate policy; floating rate
policy has been accepted instead of nominal anchor rate policy
□Governor of Central Bank, Undersecretary of Treasury and Chairman of BDDK are
resigned.
☐2 March 2001- Mr. Kemal Derviş is appointed as State Minister in charge of economy
☐16 March 2001 – TOBB Presidents Council (350 presidents of chambers and comm.
exchanges) meeting held in Ankara and declared "economic salvation war"
□31 March 2001 – "Economic and Social Council" meeting held in Ankara, need for
new economic programme with social consensus, declared by NGO members
☐14 April 2001 New Economic Programme of Government declared by Kemal Derviş
☐Undersecretary of Treasury decided to make a study in cooperation with World
Bank to improve the investment climate




Recommendations of IAC members which are arroused during the meetings are declared to the public by the Prime Minister via press conference with the participation of all members


## ROLE OF PRIVATE SECTOR IN YOIKK PROCESS

- ➤ TOBB'S OPINIONS & RECOMMENDATIONS ARE CONSIDERED IN ALL PHASES OF REGULATORY CONSULTATION PROCESSES
- >TOBB ORGANISES BIANUAL KIZILCAHAMAM INVESTMENT CONFERENCE
- ➤ TOBB PARTICIPATES IN ALL STUDIES, LEADED BY, WB, TREASURY, EU & ETC. CONCERNING INVESTMENT CLIMATE

## TOBB YOIKK WORKING GROUPS

- > TOBB has established working groups parallel to YOIKK Technical Committees. Currently, 12 technical working groups actively study on YOIKK affairs
- ➤ Each working group have about 30 members representing main chambers of industry, commerce, maritime commerce and relevant sectoral assemblies
- > Chairman of each working group represents TOBB in technical committees
- ➤ Working groups evaluate the proposals of investors and TOBB members, and prepare the main policy of TOBB within the topic of their technical committee
- > Professionals from the relevant departments of TOBB participate in the working groups as group reporter.
- TOBB YOIKK Secretariat controls and coordinates the studies of working groups and makes the necessary cooperation with Technical Committees, Treasury and private sector organizations.

- ➤ Kızılcahamam Investment Conference meets bianually since January 2003 (Kızılcahamam is a town nearby Ankara, where meetings are held)
- ➤ Participants: YOIKK & Steering Committee members, Technical Committees, private sector representatives, NGO's
- ➤ Organized by TOBB in cooperation with Undersecratariat of Treasury
- ➤ Secretarial works done by YOIKK Secretariat & TOBB YOIKK Secretariat
- ➤ Sessions held in Conference: Private sector coordination meetings to consolidate the proposal packages for action plans, Technical Committee meetings, Steering Committee meetings, YOIKK meeting.
- ➤ Outcomes : Action Plans of Technical Committees

## OTHER CONTRIBUTIONS OF TOBB ON INVESTMENT CLIMATE
